Agenda

- I. Welcome/Introductions – Cynthia  
Cynthia Mancha, opened the meeting on behalf of Tim Kelley (to come later) and those present (Angie Ortiz of Calipatria, Marjorie Stacie of Holtville, Juan Leal of Imperial, Julieta Amezcuita of San Pasqual, Monalisa Vitela of ICOE, and Philip Villamor of IVROP) introduced themselves as well
- II. Review of Perkins Indicator Data - Phil  
Review of Perkins Indicator Data was incomplete. Not all school results there, and because data on site looks exactly like IVROP's there is some doubt that this represents combination of consortium members. Nonetheless, it is believed that all areas will be significantly over state targets based on available data, and it does not look like a special goal will need to be made because of missing a target.
- III. Review of Industry Sectors / Paths supported - Phil  
(Ag & Nat. Resources, Arts/Entertainment (Graphic Design), Info. Tech., Hospitality/Tourism (Culinary) ).  
Philip Villamor, supported with input from district representatives present, reviewed The industry sectors and paths supported by the application, and emphasized that – While the industry sector advisory meetings already completed were an opportunity For input, this discussion was also an opportunity to examine if paths were successful and/or appropriate given data / local realities. Group present indicated agreement and consensus that those areas already targeted would be continued.  
\*Specific points brought up regarding culinary (this is not a path across collaborative currently. It is at Imperial and Calipatria but not budgeted for in pathways, and it is at other school sites in greater IVROP JPA. Also brought up, Calipatria looking to add to their ICT sector and Pathway with a Computer Repair Course, so this will be added to the application this year. Philip pointed out that it was with the local realities in mind that IVEDC would be reviewing local opportunities / Growing sectors.
- IV. Review of Local opportunity / Growing sectors, etc. by IVEDC – Cynthia / WDB? / IVROP  
- Latest Biofuel Progress...

Cynthia Mancha, both with a Renewable Energy Newsletter and information provided, spoke to growing biofuel related opportunities in the valley. California Ethanol and Power a company that will look to produce biofuels in various ways... possibly related to sugarcane grown specifically for this purpose and may include ag. waste products. The Keystone planning area on Hwy 118 mentioned in relation to sugarcane development. Oberon fuels, evidently doing work in north county, Brawley and Calipatria, doing work with dimethol ether. Cynthia indicated contact for these companies could be provided to those interested in exploring links.

Law Enforcement / Health / (Internships in IT sector – beyond word/excel) – Cynthia also provided information on growing law enforcement opportunities, a new private prison being constructed and will need many new law enforcement correctional officers. This, together with move to house many prisoners in county facilities (due to legal changes), which will mean a new for more Sheriff's correctional officers, sited as a reason to look at Law Enforcement. The information on Health was primarily provided by Phil (with agreement from those who have pathways there, Holtville and Imperial) about opportunities. Pharmacy Tech. has internship components in place at Imperial, and there is simply a number of Health-Science opportunities across the board, locally and state (IVEDC, Cynthia and Tim agreed). Also, Phil indicated that successful internships for IT had been created with Central this past year, Rabobank and IVC ready to have people doing internships over the summer.

- V. Possibilities for Students/Teachers to interact with Business/Community - Cynthia  
Cynthia indicated that IVEDC would/could assist with efforts to have students/teachers involved with business and community. She mentioned the Renewable Energy Conference efforts of the past and also that IVEDC has made use of several interns themselves and are looking to make sure other companies know how to take advantage of this. Sounded like their experience and plans were more for those past high school.
