AUDIT SERVICES FOR FISCAL YEARS 2018/19, 2019/20, AND 2020/21. A motion was made by Mr. Jimenez and seconded by Ms. Sassie to award Wilkinson & Hadley King & Co, LLP, the auditing contract services for fiscal years 2018/19, 2019/20, and 2020/21. Motion carried unanimously.

INFORMATIONAL ITEMS:

MONTHLY BUDGET UPDATE. Mr. De La Torre reviewed the Monthly Budget Update report. He added \$8,003 under the IVROP Customized Services MRT budget. He is projecting deficit spending.

IVROP COMMUNITY FOUNDATION. Mr. Obergfell shared information regarding the new Gala location-St. Mary's Banquet Hall. He reminded the board that the IVROPCF Scholarship Applications are due Thursday, April 19, 2018. He announced the sponsors this year are Marianne V. Fenley State Farm, El Centro Regional Medical Center, Vesper Society, Sun Community Federal Credit Union, United Families, Imperial Valley Press and Imperial Printers.

CTE UPDATE. Mr. Campos announced the IVROP Showcase and Recognition Ceremony is scheduled for April 17, 2018. He shared the Outstanding Student List. He also mentioned the different committees for the Showcase. He reminded the board of the following events: AG Summit on March 15th, Welding Event on March 22nd and the Law Enforcement Competition on March 28th. Mr. Obergfell shared the new WASC process. Mr. Campos provided information in regards to the new WASC process.

Mr. Campos provided an update for ICOE Alternative Education. He mentioned Ms. Roxine Zamora is being provided with support by Ms. Marisabel Dorantes, Career Specialist. Mr. Campos will be meeting with Ms. Monalisa Vitela on March 19th. Mr. Victor Nuno has cleared the credential process to teach the Design, Visual, and Media Arts at Del Rio.

PRESENTATION:

Mr. Luis Torres, Program Manager presented on Project ACE and Project Rising Stars. Project ACE is a youth program for current and former foster youth between the ages of 16-21. Project Rising Stars is a youth program for current foster youth between the ages of 0-15. Project ACE and Project Rising Stars work in collaborative partnership with Social Services. The three main goals for Project 1) Rising Stars are improving academic performance and school attendance of local foster youth, 2) linking youth to after-school or community programs, 3) improving self-esteem and leadership skills. Adventures are held for the younger kids and workshops are held for the older youth. Seventy to one-hundred children attend the activities that are provided by the projects.

Project ACE and Project Rising Stars receive a lot of support from the community. Mr. Torres explained life and growing up in the foster care system. He provided information on the experience of an average academic foster youth. In the summer Project ACE partners with Imperial Valley College to provide college prep classes. Youth sixteen years and older are provided with Career Exploration, Job Readiness Training, College Prep, Self-Esteem Enhancement and Life Skills workshops. Mr. Torres provided information on Anthony Trucks, keynote speaker that presented at the annual college and CTE conference. Project ACE also provide awareness activities. On May 24th students K-12 will recognized for doing well in school. Mr. Torres shared Mr. Abraham Anaya and Ms. Lucerito Tirado were Project ACE participants and are now current IVROP employees.

Ms. Leslie Romero shared her experience as a Project ACE participant. Ms. Romero has been in Project ACE since she was sixteen years old. She is currently enrolled in the IVROP Nursing Assistant Class. She is a senior in high school. She's gained leadership skills and has been encouraged to take leadership roles.

Ms. Fernanda Hernandez is a junior in high school. Ms. Hernandez thanked Ms. Estela Diaz and Mr. Abraham Anaya for all the support she has received. She said they're always available for the participants. She has also received academic support.

Mr. Oswaldo Arreaza shared he has gained job skills and life skills. He is learning to speak English. He mentioned Project ACE are like family to him. They inspire him to continue to improve. They had taught him how to manage his money and they didn't judge him.
