VARIABLE TERM WAVIER. A motion was made by Mr. Jimenez and seconded by Mr. Calderon to approve the Variable Term Waiver to employ Ms. Elizabeth Flores and Mr. Ethan Ming CTE instructors on the basis of a Variable Term Waiver (English Learner) for the 2015-2016 school year as part of the IVROP CTE MOU Fee for Services. *Motion carried unanimously.*

NEW BUSINESS: CARL D. PERKINS 131 – SECONDARY (CONSORTIUM) FUNDS. A motion was made by Mr. Hester and seconded by Mr. Sadorra to approve the submittal of the Carl D. Perkins 131 application for funding. *Motion carried unanimously*.

ACCEPT THE CONTINUATION OF. A motion was made by Mr. Sadorra and seconded by Mr. Hester to accept the funding for Project ACE (\$185,000); Project ACE THP-Plus (\$112,387); Project CARE (\$18,711); Project Éxito (\$1,019,000); Project Mi Familia (\$178,395.80); Project Family Visitation (\$92,991.08); Project NENES (\$182,211); Project WORK (\$1,125,741.79), and Project WORK ESE (\$1,176, 495.60). *Motion carried unanimously.*

ACCEPT FUNDING OF. A motion was made by Mr. Jimenez and seconded by Mr. Calderon to accept funding for Project TOY (\$615,788). *Motion carried unanimously.*

INFORMATIONAL ITEMS:

MONTHLY BUDGET UPDATE. Ms. Duron made reference to the Monthly Budget Update.

IVROP COMMUNITY FOUNDATION. Mr Obergfell informed the board that the IVROPCF Board met on Tuesday, August 18th. The IVROPCF board received Career Technical Education (CTE) Student Leadership Follow-up Reports from Central Union High School Mock Trial, Central Union High School Migrant Debate Club, Central Union High School Future Leaders of America, Imperial High School HOSA, and Brawley Union High School HOSA. The IVROPCF awarded IVROP Project TOY and Calexico High School BullDocs a \$500 CTE Student Leadership Organization Award. Mr. Obergfell announced the Dancing with the Stars has been scheduled for Friday, May 6, 2016 at the Barbara Worth Country Club. The net income for the 2015 Dancing with the Stars was over \$15,000 and \$12,000 were awarded in scholarships.

WASC UPDATE. Mr. Villamor gave an update on WASC.

CTE UPDATE. Mr. Villamor gave the board an update on the CTE Department Meetings. Teachers, counselors, and principals will be invited to the Industry Sector Advisory Meetings. The Agriculture & Natural Resources Advisory Meeting was moved to Golden Corral. Mr. Jimenez requested to receive e-mail invitations for the Advisory Meetings. Ms. Garcia mentioned the teachers were happy to receive the binders provided by IVROP. CCPT provided an additional Guidance Technician. The Central Union High School Law Enforcement Class is now A-G accredited.

PRESENTATION: Mr. Obergfell introduced Ms. Flores, Project RISE Project Specialist. Ms. Flores provided the board with a development asset overview. The pilot year began with three high schools (Brawley Union High School, Central Union High School, and Southwest High School). She is currently working with high schools to embed developmental asset activities into existing programs and curriculum. A parent volunteer group will be developed in each high school to assist in providing enriching

development asset opportunities. An asset rich internship program will be developed that will provide opportunity for youth to acquire life skills and develop valuable relationships with positive adult role models. The goal is to administer the survey to Calexico High School and Imperial High School by January 2016; Calipatria High School, Holtville High School, and San Pasqual High School by January 2017. Ms. Flores mentioned the forty developmental assets.
