#### Recommendation:

The Housing Support Program (HSP) helps homeless CalWORKs families find permanent housing. This program is operated by Imperial Valley Regional Occupational Program in partnership with the Imperial County Department of Social Services. Participants work one-on-one with Case Manager to determine strategies to help them obtain and maintain permanent housing and achieve self-sufficiency.

The Imperial Valley Regional Occupational Program (IVROP) is proposing an extension of the youth program, entitled Project ACE (Accessing Careers through Education) Rising Stars. This program would serve foster children and youth between the ages of 0-16 years old. Project Rising Stars will also serve children and youth between the ages of 0 to 18 who have experienced trauma from neglect, physical or mental abuse, exposure to domestic violence, experiencing homelessness, loss of family members, exposure to drug abuse, community violence or extreme poverty. The program would begin October 1, 2017 and operate through September 30, 2018. This program will collaborate with local school districts and community agencies to link participating youth to programs that can offer services such as academic support, enrichment activities, field trips, counseling, mentoring, daycare, early childhood education, college prep, camping trips, leadership development and career exploration. Accept funding for the Housing Support Program (\$500,000) and Project Rising Stars (\$161,296), as presented in Exhibit 8(a1) and 8(a2).
